Specific Conditions:

Ensure strict adherence to authorization conditions along with the following points and send compliance report within one month from receipt of this authorization.

- 1- The Authorization shall comply with provisions of the Environment (Protection) Act 1986 and the Rules made there under.
 - 2- The Authorization or its renewal shall be produced for inspection at the request of an officer, Authorized by the Board.
 - 3- The Authorized person shall not rent, lend, transfer or otherwise transport the bio-medical waste without obtaining prior permission of the prescribed authority.
 - 4- It is the duty of the Authorized person to take prior permission of the Board to close down the facility and such other terms and conditions may be stipulated by the prescribed authority.
 - 5- Any unauthorized change in personnel, equipment or working condition as mentioned in the application by the person authorized shall constitute a breach of his authorization.
 - 6- Bio Medical Waste shall not be mixed with other waste.
 - 7- Needle cutter /shredders should be installed, maintained & operated to its reuse.
 - 8- Segregated Bio-Medical Waste in deficolour-coded bags shall be handed over to a valid agency as engaged for disposal.
 - 9- You shall also ensure that untreated Bio-Medical Waste shall be transported on regular basis by the engaged agency only in such vehicle as may be authorized for the purpose by the Board
 - 10- Bio-Medical Waste shall be segregated into containers/bags at the point of generation in accordance with schedule I. prior to its storage, transportation, treatment and disposal. The container shall be labelled as per provision. Record of Bio-Medical Waste for Incineration and other waste must be maintained in the Hospital.
 - 11- It shall be your sole responsibility to engage a valid authorized agency engage for C.B.T.F. (By U.P. Pollution Control Board) for the disposal of Bio-Medical Waste.
 - 12- No untreated biomedical waste shall be kept stored beyond a period of 48 hours in compliance of Rule 8 of Bio-Medical Waste (Management and Handling) Rules-2016.
 - 13- You shall submit an annual report to the U.P. Pollution Control Board in form IV by 30th June every year for a period from January to December. And include information about the categories and quantities of Bio-Medical Waste during the preceding year.
- This authorization is issued on the basis of agreement made in between the unit and M/s SMS water grace mediwaste Pvt. Ltd, Lucknow In case the agreement is breached /cancelled, the authorization issued to you will automatically be deemed as cancelled.
- 14- You shall maintain records related to the generation, collection, reception, storage, transportation, Treatment and disposal and/or any form of handling of Bio-Medical Waste in accordance with rules and guidelines. All records shall be subject to inspection and verification by the board at any time.
 - 15- It is within the power and functions of U.P. Pollution Control Board to modify/revoke the terms and conditions of the Authorization issued under the Rule of the Bio-Medical Waste Management Rules-2016.
 - 16- You are hereby directed to comply the stipulated above, mentioned conditions and submit the compliance report and steps taken in this regard within a month so that capacity of the facility may be verified failing which the authorization may be revoked and necessary legal proceeding shall be initiated.
 - 17- The Bio-Medical Waste shall not be disposed in open place in the premises.
 - 18- Strict Compliance of Rule 18 and all other provisions of BMW Rule 2016 must be ensured.
 - 19- The mercury contaminated Bio Medical Waste shall be properly segregated in the healthcare facility & the same shall be treated and disposed by CBMWTF in compliance of the said rule and Hazardous Waste (Management Handling & Trans Boundary Movement) Rules, 2008 and thereof.
 - 20- You shall also ensure that the validity of CBWTF for the disposal of Bio Medical Waste extended before expired the time limit & submitted to this office otherwise your authorization may be revoked.

- 21- The Registration Certificate issued by Chief Medical Officer shall be submitted within one-month time.
- 22- Necessary Consent under section 25/26 of Water (Prevention & Control of Pollution) Act 1974 and under section 21 of Air (Prevention & Control of Pollution) Act 1981 shall be obtained within 03 months.
- 23- Remaining Authorization fees shall be submitted within fifteen days. You are directed to focus your attention on above mentioned conditions and submit compliance report in due time to this office, otherwise your authorization may be revoked.

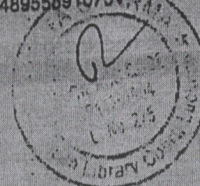

The expression of both the parties shall mean and include the parties, their respective legal heirs, successors, legal representatives, administrators, executors and assignees. Whereas the Service Provider has signed an agreement (MOU) with Lucknow Nagar Nigam, Lucknow under PPP model as JV and has been duly authorized by the Uttar Pradesh Pollution Control Board (UPPCB), under rule 8(4) of the & for the amended till date operating a facility for the collection, Reception, Transportation, Treatment, Storage and disposal of the bio- Medical Waste. And whereas the Waste Generator is desirous of outsourcing the disposal of its Bio-Medical Waste and have approached the service provider for providing its service in this regard on Govt. approved rates and after discussions, both the parties are agreed to enter into this agreement on the terms and conditions narrated herein after:-

NOW THIS AGREEMENT witnessed the following terms & conditions to be performed to by both the parties to the present agreement.

1. That the Waste Generator will segregate, pack and label the bio-medical waste in the color coded bags from its waste generation points as per guidelines and keep the said packed waste ready for collection by the staff of the Service Provider. The Service Provider will collect Bio-Medical waste which is properly segregated and packed in accordance with the guidelines. The record of the collected waste shall be maintained by the Waste Generator with the acknowledgements signatures of the collection staff of the Service Provider to submit the annual Report to the concern Pollution Board in the prescribed format.
2. That the Service Provider will charge the Waste Generator, being Clinic/Pathological Lab/Diagnostic Centre etc. (Not having bed facilities) and being a Nursing Home/Hospital (Having Bed facilities) as per the following schedule of rates:
 - (i) Twelve months **security deposit** will be mandatory for HCFs which will be refundable/adjustable at the time of termination of services.
 - (ii) GST no..... &/or PANCARD NO.....Pancard Holders Name.....Of client with Minimum charges of Rs. 1000/- /-Month (Rupees one thousand only) and GST @ 12% will be charge on the per month rate for theBedded hospital subject to a maximum collection of waste up to Kgs. (**450gm to 500gm per bed per day**) Extra quantity of waste will be chargeable@ Rs. 25/-per Kg. The service tax if applicable will be borne by the Waste Generator upon the respective billings.
 - (iii) This agreement will be valid for **5 years** from the date of agreement & there will be **7% increment** every year on the charges mentioned above in 2(ii).



- (iv) The rates enumerated in clause 2 (ii) above may be varied at any given point of time due to hike in fuel Price, Wages for Labor and negotiation with any unanimous body i.e. DMA/IMA at District or state level or any other factor which may affect the cost.

That the waste generator undertakes to make the payment through 'Account Payee Cheque or Demand Draft' in favor of the M/s. **SMS WATERGRACE MEDIWASTE MANAGEMENT PVT. LTD.** On or before 7th day of each successive month and thereafter the interest @ 18% for p.a. shall be payable to Service Provider if the payment is not made within the stipulated period.

3. (a) Notwithstanding the aforesaid terms this agreement may be terminated by either party by giving 30 days written notice. However this requirement of 30 days notice shall not be applicable in the event the service charges are not paid by the Second Party as provided in Clause 3 of this agreement or upon the occurrence of any of events specified in Clause 5b (i),(ii) in which events the service would be suspended/ terminated forthwith.

- (b) Notwithstanding the aforesaid terms and conditions:-

- The Service Provider will be at liberty to discontinue this service to the Waste generator in the event: the Waste Generator does not pay the service charges.
- The waste generator and Service Provider both are to strictly follow the guidelines of the during segregation, collection and Transportation of the bio- Medical Waste except due to the circumstances under force major clause and the circumstances beyond their control.

- (c) That upon expiry of the term or the earlier termination of this agreement, the accounts shall be settled and the refundable and interest free Advance deposit referred to in Clause 3 above shall be returned without any interest thereon to the Waste Generator.

4. That all the taxes, such as Contract Sales tax, Service Tax etc., if applicable, shall be paid and borne by the Waste Generator.
5. The neither party shall transfer and /or assign the rights granted under this agreement without the prior intimation and written permission of the other party and without obtaining a written undertaking by the proposed assignee/transferee agreeing to assume all of the said party 's obligations under this agreement and to abide by all the obligations and covenants contained herein.
6. That this agreement shall be governed by the laws of India and shall be interpreted and construed in accordance with the laws of India and Subject to the jurisdiction of Courts at Lucknow , shall have exclusive jurisdiction to try, entertain and dispose between the parties thereto. All the notice, request, demands and other communications, required/permitted to be given under this Agreement shall be in writing.
7. That the waste generator should get from time to time the service contract Agreement renewed from the service provider one month before the expiry of the validity of the Agreement. The Waste generator further undertakes to keep the validity period of the agreement for a minimum period of one year from the date of service as per pollution

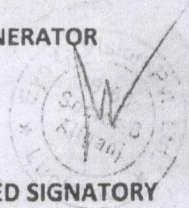


Control Committee/Board Rule and in between if the agreement is cancelled, they should directly intimate pollution control committee / Board with adequate reason about the cancellation of the agreement, failing which, all the consequence and penalties will be borne by the waste generator. Further, the waste generator also undertakes to give one month notice in writing if they want to discontinue the service and wish to switch over to another service provider failing which, they have to pay the service charge equivalent in one month minimum service charges to the service provider in lieu of one month notice period.

8. That in case the service contract agreement gets misplaced at the waste generator end, then an additional Rs. 100/- will be charged from the waste generator for issuing the agreement once again.
9. That the waste generator further undertakes to sign every page of the agreement and return both copies of the agreement to the service provider's signature and the services provider will return the duplicate copy of the agreement to the waste generator. On receipt of the agreement, the Waste generator will submit a copy of the agreement with the date of service expiry to the pollution control committee /board.
10. The term of this Agreement shall be for a period 5 Years.
11. That in case there is any change in the constitution of waste generator the same shall be informed forth with to the service provider.
12. That both the parties undertake to remain bound by the term and conditions set out herein above.
